2. Competent Authority, Nodal Officers and their functions:

2.1) The Admission process will be carried out through the Competent Authority and the authorized officers. The Director, Medical Education and Research, Mumbai shall be the competent authority in this regard and the institution wise Nodal officers are as follows:

2.2) Functions of Competent Authority:

The Competent Authority, through the nodal officers appointed by it, shall implement the admission process and control the selection process in accordance with the said rules and act as the appellate authority in this regard if the candidates make a report. The competent authority shall make necessary arrangements for the enforcement of these rules. The competent authority or the nodal officers appointed to present in the case of petitions filed in the Courts in this regard on behalf of the Maharashtra Government as per the instructions given from time to time.

Legal Jurisdiction:

All disputes pertaining to the selection process shall fall within the Jurisdiction of courts at Mumbai only. The Competent Authority shall be the legal person in whose name the Government of Maharashtra may sue or may be sued.

2.3) Function of Nodal Officers:

The Nodal Officers under the control of the competent authority will distribute the admissionforms. Accept and scrutinizeapplication forms and publishthe merit list. If any candidate Challenge the decision regarding admission in the court, in that case as well as directed by the competent authorityfrom time-to-timeNodalofficers has to plead in Courts on behalf of the Government and/or Competent Authority.

2.4) A candidate seeking admission should submit a single application for only one academic course (M.Sc. Nursing / P.B.B.Sc. Nursing / P.B. Diploma Paediatric Nursing)/Post Basic Diploma in Psychiatric / Mental Health Nursingin the prescribed format at the respective institute. If a candidate submits an application for more than one academic course, his / her application will not be considered for any of the courses.

2.5) Prescribed specimen application forms may be obtained from the respective institute. Applications fully filled in all aspects should be submitted through proper channel to DMER By the Inservice candidates under DMER/DHS on or before the date notified by the competent authority. Late applications will not be accepted at any condition.

Private candidates will submit their complete fully filled form to the respective institute. Merit List will be displayed at respective institute by the Nodal officers.

2.6) Grievance Redressal Authority (All General): Under Section 9 of the Act, any complaint regarding the admission process shall be dealt with by the Competent Authority / Nodal Officers.

3. Eligibility Criteria for MSC Nursing

3.1) The candidates having Indian citizenship will be eligible for admission.(Certificate of Nationality must be attached.)

3.2) Maximum age limit will be 45 years for the General category and 50 years for reserved category as on 30th September 2023.

4. Educational Qualificationand Work Experience:

4.1) Candidate should have passed Higher Secondary Certificate Examination of Maharashtra State Board of Secondary Examination or equivalent examination recognized in Maharashtra State with English subject.

4.2) Candidates whose parents are natives of Maharashtra State, but the candidates have passed Secondary School Examination or equivalent and/or Higher Secondary School Examination from an institution outside the State of Maharashtra, such candidate is also

eligible for admission, provided such candidates must submit original Domicile Certificate duly signed by the District Magistrate or Metropolitan Magistrate.

4.3) Candidate should be a resident of Maharashtra State and should have passed the examination of Basic B.Sc. Nursing /P.B.BSc.Nursing/P.B.BSc.(IGNOU) Nursing course must have passed from Institute / Study Centre recognized by Indian Nursing Council and Maharashtra Nursing Council.

4.4) Candidate should be registered as a Nurse and Midwife with Maharashtra Nursing Councilis mandatory. Also, the said registration should have been renewed till 2028.

4.5) It is mandatory for the candidate to have one-year work experience after registration with Maharashtra Nursing Council as Nurse and Midwife.

4.6) Government In-service candidates must have completed five years of continuous Government service. The candidate must submit a work experience certificate from the authority.

4.7) In-service candidates should submit their applications through proper channel only. A merit list will be prepared based on the applications received through proper channelwithin the prescribed time. Application Received late will not be considered. Late, via Post,Xerox or Photocopies of applications will not be accepted.

5. <u>Medical Certificate of Physical Fitness</u>: Candidate must be physically and mentally fit to complete this course. Candidates should submit a Medical Certificate from the District Surgeon/Medical Superintendent of the Government Hospital regarding their physical fitness along with the application form. Also, Persons with Disabilities (Equal Opportunities, Full Participation and Protection of Rights) Act, 1995, Section 2 (T) the disability of the candidate must be at least 40% of locomotors for the said reservation. The Locomotors disability should not exceed more than 50%. After admission if the candidate is found to be physically and/or mentally unfit, the admission of such candidates will be cancelled.</u>

6.1.1) Reservation for Reserved category candidatesare as follows -

Reservation policy will be followed for admission as per the existing rules of Maharashtra Government.

6.1.2) Applicants for reserved categories (1) to (7) mentioned above must attach the caste certificate &Caste Validity Certificate from the competent authority with the application form.

6.1.3) The benefit of reservation shall not be admissible to the candidates belonging to the creamy layergroups of above (3) to (7) categories. However, is mandatory to submit the Non - creamy layer certificate from the competent authority valid up to 31/03/2023. As per Government Resolution, Social Justice, Cultural Work and Special Assistance No.CBC.10/2008/Pra.No.697/ dated 13thJanuary2009, in revised prescribed format that they do not fall under the creamy layer category. Old Non-Creamy Layer Certificate will not be considered.

6.1.4) If the seats in the reserved category (1) to (7) remain vacant, shall be filled among the remaining reserved category according to their inter-Group-merit. If the seats still remain vacant then, these seats will be filled by Inter- se –merit from the candidate from the General category.

6.1.5) Reservation Inter-se Group will be as follows-

6.1.6) While considering reservation category seats, reserved candidates who have been selected on merit (without benefit of reservation) such seats will not be counted for reserved seats.

6.2) Reservation for candidates with disabilities (PWD)shall be indicated as below:

6.2.1) As per the provision of Revised Notification of Indian Nursing Council, New Delhi, No F-1.5/2018 /INC dated 10/04/2019, 5% of the total seats will be reserved for locomotors disability candidates. If Candidates are not available for these seats, those seats will be filled from among the candidates from the Open category.

6.2.2) Candidates applying for seats reserved for persons with disability must submit a certificate of their disability from the competent authority signed by Civil Surgeon/Medical Board of District General Hospitals/Medical Superintendent of Government Medical College and Hospital or Director, All India Institute of Physical Medicine and Rehabilitation, Haji

Ali, Mumbai in the prescribed format. Candidates should attach the certified true copy of such certificate along with their application. Candidate must have 40% of Locomotors disability Candidates having disability more than 50% are not eligible for admission for Nursing courses Disability other than Locomotors is not allowed as per the rules. However, the verification of disability of the candidates will be done through a medical board constituted by the competent authority for this purpose.

6.3) Reservation for orphan candidates:

As per Govt. Resolution dated--2.4.2018, 1 % parallel reservation in open category will be applicable to the said candidate in education and employment Accordingly, the candidates should submit the certificate from Department of Women and Child Development.

6.4) Reservation for Economically Weaker Sections (EWS):

As per Government Resolution No. 4015/P.No.3.2/16-A dated .12th February 2019, a parallel reservation of 10 % from open category to be given to the Economically Weaker Sections. Submission of certificate from competent authority in prescribed form (Annexure-C) shall be mandatory for availing reservation for Economically Weaker Section (EWS).

7. Educational Qualifications to be considered for selection process:

7.1) The selection of candidates will be done on the basis of aggregate marks obtained in all years examination of Basic B.Sc Nursing / P.B.B.Sc Nursing / P.B.B.Sc. (IGNOU). If the candidates get equal marks in under graduate course, the following procedure will be adopted to determine the inter merit in respect of them: -

Tie Breakers: -

7.2)**First-Preference:** Aggregate marks obtained by the candidate in the Higher Secondary School Examination (Std12th) will be taken in to consideration while deciding the first preference.

7.3)**Second-Preference:** Aggregate marks obtained by the candidate in the SSC (Std10th) will be taken in to consideration while deciding the second preference.

7.4) Third Preference: The candidate those who are senior in age will be given preference

8. Selection Process:

8.1) Provisional merit list of eligible candidates will be displayed on the notice board of office of the Principal of all the respective Nursing colleges. Objections raised by the candidates regarding provisional Merit List will be consider (With Correction if necessary)

and will be published at the place specified above within a prescribed period mentioned in the schedule of admission Brochure.

8.2) <u>Eligible candidates qualified as per merit list should report for counselling on given date</u> (In information brochure) with all original documents atPreferred Nursing Colleges.

8. 3) The final selection list of the candidates selected on the basis of merit in the counselling process will be published at the place specified above. Selection orders will be issue to the selected candidates at the respective institute. Candidates who do not join the institute within fifteen days of selection will not have any claim for admission on the selected seat. Non-Admission of the candidates within the prescribed period vacant seats will be filled within the prescribed period from the waiting list according to the quota. The final decision regarding the selection process will rest with selection committee.

8.4) Candidates must submit the original documents immediately to the principal of the concerned institution at the time of admission. Also, the payment of the prescribed fee shall be subsequently pay by the selected candidate.

8.5) Vacancies in the concerned institution for any reason shall be filled from the candidates from the waiting list.

8.6) If a candidate fails to report for the course within 15 days from the commencement of the first session despite having paid the prescribed fee, the Principal of the concerned institute reserves the right to cancel his/her admission and in such case the candidate will not get any refund of the fees paid.

8.7) Final admission of selected candidate will be subject to the approval by Maharashtra University of Health Sciences, Nashik.

8.8) It is hereby clarified that, all candidates who do not appear at the Institute after selection or fail to comply with the necessary formalities within the prescribed time shall not be eligible to take admission for next two years. In case of cancellation of admission after the cut-off date of the University and failure to complete the said course within four years, the amount Rs.1,50,000/- (One Lakh Fifty Thousand only) should to be paid as a penalty for lapse of seat.

8.9) All legal matters pertaining to the admission process will be dealt within the jurisdiction of the Mumbai.

9. For In-Service Government Candidates:

According to Maharashtra Civil Service Leave Rules, 1981 Chapter Seven Study Leave (80 to93)

9.1) In-service Government candidates' procedure will be followed regarding study leave as per the provisions of Maharashtra Civil Service Study Leave Rules 80 to 93 of the Leave Rules, 1981.

9.2) The decision regarding study leave will be taken by the Medical Education and research, Government of Maharashtra.

10. Admission form and Documents to be submitted for MSc Nursing.

10.1) All applicants must submit the attested true copies of following documents with the admission form:

1) Higher Secondary School Certificate Examination 12th (10+2) or equivalent examination Mark sheet and certificate.

2) Secondary School Certificate (SSC) and mark sheet.

3) Maharashtra Nursing Council Registration and Renewal Certificate.

4) Basic B.Sc./P. B. BSc Nursing / P.B.B.Sc. Nursing (IGNOU) Exam Passing Certificate and Mark Sheets of each year.

5) Basic B.Sc./P. B. B.Sc/P.B.B.Sc. (IGNOU) Nursing College Leaving Certificate

6) Domicile Certificate issued by the competent authority.

7) Age &Nationality Certificate

8) Medical Fitness Certificate

9) Migration Certificate, if applicable

10) Caste certificate (For Reserved category)

11) Caste Validity Certificate (For Reserved category)

12) Non-Creamy Layer Certificate (for candidates applying for reserved seats in Reserved category other than Scheduled Castes and Scheduled Tribes) having validity till 31st March 2023.

13) For Handicap, Orphan and Economically Weaker Section (EWS) candidates, certificate in prescribed format by the Competent Authority.

(14) Experience Certificate form the Head of the Institute.

(15) Attempt Certificate

(16) No Objection Certificate head of the Institute for Government Candidate.

10.2) Admission forms will not be considered unless the following conditions are met:

10.2.1) Admission forms should be duly, accurately and completely filled.

10.2.2) Substantiation of the claim made in the application form should be accepted by the true copies of all necessary certificates. Any admission application not accompanied by certified true copies will not be considered.

10.2.3) Application for Admission should be received at the office of the authorized Nodal Officer / Principal by the final scheduled date and time.

10.2.4) No such application shall be considered if the attested Xerox copies of all necessary certificates are not attached with the application.

10.2.5) At the time of admission all necessary original certificates shall be handed over to the Principal of the concerned Colleges. These original certificates will be returned to the candidates after completing the course or leaving the institution.

10.2.6) Photocopies of certificates submitted later for any reason after submission of admission application will not be accepted. Candidate should fill admission form properly and carefully. If a candidate is found to have knowingly given false information in the application, his/her admission will be cancelled immediately and the fees paid by him/her will not be refunded. Also, such a candidate will be disqualified for the said course.

10.2.7) Candidate working in Government service should submit their applications to parent institution through proper channel. The said institution should do scrutiny and submit the application to the Directorate, Medical Education and research within the prescribed time. The Respective Nursing colleges will receive the admission forms from the DMER/DHS through proper channel within prescribed time frame. Applications not received through proper channel will not be considered for admission.

11. Fees and Scholarships etc.:

11.1) The tuition fees for this course shall be as per the Government of Maharashtra from time to time.

11.2) Hostel facility will be depended on the availability of the accommodation. All the candidates may not get hostel facilities.

11.3) Selected candidates will have to pay the first-year course fees at the time of admission. Thereafter the prescribed fees have to be paid at the beginning of each academic year. Admission of candidates will be confirmed only after payment of admission fees.

11.4) Fees structure as per Government Decision No. AMC - 1007/628/P No. 148/07/Shikshan-2 dated 01 March 2011 and Letter no DMER-11011/9/2022 CETI dated 25/4/2022.

Apart from the above fees University examination and other fees will be charged as per university rules. will remain permissible as per the orders of the Government from time to time.

11.5) Education fee waiver schemes such as, Schemes for Reserved Category, children of exservicemen, Primary/Secondary school teachers etc. will be admissible to the candidates as per the orders of the Government of Maharashtra in force from time to time.

11.6) The admission brochure and admission form fees for MSc Nursing at INE, Mumbai , College of Nursing, GMCH, Nagpur and Maharashtra Institute of Mental Health, Pune will be Rs.2000/- for open category and Rs.1500/- for reserved category. The will be for PBBSc, PB Paediatric Nursing Diploma and PB Psychiatric Nursing Diploma. Rs.1000/- for open category and Rs.500/- for reserved category.

12. Conduct and discipline for the students

12.1) It is mandatory for the selected candidate to pay the prescribed tuition fees in time.

12.2) It is mandatory to submit three different bonds namely Affidavit for Educational Gap, Affidavit for Laps of Seat and Affidavit for 100% attendance along with all the original documents.

12. 3) Admitted candidates shall be bounded by the relevant rules of conduct and discipline of the Institute and Maharashtra University of Health Sciences.

12.4) If any student is found to be involved in Anti-national activities against the provisions of the laws and regulations of the Government from time to time, the Principal may rusticate the student from the institution without prior notice.

12.5) Selected candidates should not remain absent in the academic session. All absent candidates will be dealt with as per rules. However, in case of long absentin-service

candidates, a written monthly report will be sent by the institute to the concerned Institute of the candidates.

12.6) Any statement or information provided by the candidate in the application form is found to be false/incorrect at any time thereafter, his/her admission will be cancelled. The fees paid by him/her will be forfeited and he may be removed from the college by the Principal and action will be taken against him as per Government rules & MUHS.

12.7) If student seeking admission has been involved in ragging in the past will be rejected. If it is found that the student was involved in ragging even after admission, he will be expelled as per the MUHS rules.

12.8) It is mandatory for the student to complete the PBBSC/ MSc nursing course within 4 years as per the norms of Indian Nursing Council, New Delhi and Maharashtra University of Health Sciences, Nashik.
